Schengen Visa Requirements According to Applicant's Employment Status  
Specific required documents, based on visa applicant's employment status are as following:

- **For employees:**
  - Employment Letter.
  - Salary Slip of Last 03 Months
  - Current bank statement of the latest 6 months.
  - Leave permission from the employer.
  - Income Tax Return (ITR) form or Certificate of Income Tax deducted at the source of salary.
- **For the self-employed:**
  - Business Letter
  - A copy of your business license.
  - Company bank statement of the latest 6 months.
  - NTN & Income Tax Return (ITR) Of Last 02 Years
- **For students:**
  - Proof of enrollment.
  - No objection letter from School or University.
- **For retirees:**
  - Pension statement of the latest 6 months.
- **If unemployed and married to an EU citizen:**
  - Confirmation of Employment letter, no older than three months, from their spouse's employer stating the position held within the company as well as the starting date.
  - Spouse's valid passport.
  - An official marriage certificate.
